

FloorBoy XL-300 Hire Agreement

Vienna Woods Ltd trading as FirstFloor

1. Definitions

- 1.1 **Owner:** Vienna Woods Ltd t/a FirstFloor, its successors and assigns.
- 1.2 **Hirer:** The individual or entity hiring the FloorBoy XL-300 machine.
- 1.3 **Equipment:** Floorservice FloorBoy XL-300 single disc machine and any accessories provided for hire.
- 1.4 **Hire Period:** The period from the time the Hirer takes possession of the Equipment until it is returned to the Owner.
- 1.5 **Charges:** All hire fees, cleaning charges, late return fees, repair costs, or replacement costs if applicable.

2. Agreement

- 2.1 The Hirer agrees to hire the Equipment on these terms and conditions.
- 2.2 By signing this agreement, the Hirer acknowledges these terms are binding.

3. Use of Equipment

- 3.1 The Hirer must:
- Use the Equipment safely and for its intended purpose only.
 - Ensure all users are competent and follow the manufacturer's instructions.
 - Comply with all relevant health and safety legislation.
- 3.2 The Equipment must not be sublet, loaned, or used at any unauthorised location.
- 3.3 The Hirer is responsible for ensuring the site and power supply are suitable for operation.

4. Disclaimer of Liability

- 4.1 The Hirer acknowledges that the FloorBoy XL-300 is a powerful machine and improper use may result in damage to floors, furniture, or other property.
- 4.2 The Owner accepts no responsibility or liability for any damage caused to the Hirer's floors, property, or any other surfaces during the hire period.
- 4.3 The Hirer accepts full responsibility for the safe and correct operation of the Equipment and any consequences arising from its use.
- 4.4 The Hirer indemnifies the Owner against any claims, costs, or damages arising from the Hirer's use or misuse of the Equipment.

5. Collection and Return

5.1 The Hirer must return the Equipment on or before the agreed date and time.

5.2 Late returns will incur additional charges.

5.3 Equipment must be returned in clean and undamaged condition.

6. Credit Card Authority

The Hirer authorises Vienna Woods Ltd t/a FirstFloor to charge the credit card detailed below for:

- Any damage, loss, or theft of the Equipment during the hire period.
- Cleaning fees if the Equipment is returned excessively dirty.
- Additional hire fees for late return.

The Hirer agrees these charges may be made without requiring further authorisation.

7. Consumer Guarantees Act 1993

7.1 If the Hirer hires the Equipment for personal use, this agreement is subject to the Consumer Guarantees Act 1993.

7.2 If for business purposes, the Consumer Guarantees Act does not apply.

8. Governing Law

This agreement is governed by the laws of New Zealand.
